That section 5.1.14.2.d.iii. Off-Street Parking of the Revised Code of Ordinances 1990, as amended be further amended as follows:

(iii) As permitted by the Planning Board, places of worship located in the BP and RC District, provided that the minimum number of spaces required for a development proposal by said places of worship shall be available on a public street within 1,000 feet of the place of worship.
